QS scheme for meat and meat products

Agriculture coordinators

The fees for scheme participation plus the applicable value added tax are set and calculated on 1 July each year (= assessment date). The lump sum fees for scheme participation cover the cost of scheme participation and the administrative expenses incurred by QS. The fees for scheme participation cannot be refunded if the scheme participant is responsible for the termination of the scheme agreement.

⁴ Regardless of the number of vehicles per company. Only applies to (commercial) livestock hauliers as service providers. Does not apply to farm businesses that are scheme participants in the "meat and meat products" supply chain and have their own livestock vehicles.

The fees for scheme participation cannot be refunded if the scheme participant is responsible for the termination of the scheme agreement.

The lump sum fees for scheme participation cover the cost of scheme participation and the administrative expenses incurred by QS. The fees for scheme participation cannot be refunded if the scheme participant is responsible for the termination of the scheme agreement.

¹ Applies to companies that store packaged and unpackaged foodstuffs at their own locations but do not own the goods. The company may also carry out activities that are related to product transportation and logistics but do not alter the product (e.g. re-palletising, repacking, freezing and defrosting). Companies that also participate in the QS scheme as part of the logistics stage (fruit, vegetables, potatoes) are only required to pay the fee once.

² The number of locations registered with QS is captured on 30 September each year.

The lump sum fees for scheme participation cover the cost of scheme participation and the administrative expenses incurred by QS. The fees for scheme participation cannot be refunded if the scheme participant is responsible for the termination of the scheme agreement.

Butchery

The fees for scheme participation – plus the applicable value added tax – are due for payment at the beginning of each contract year. The lump sum fees for scheme participation cover the cost of scheme participation and the administrative expenses incurred by QS. The fees for scheme participation cannot be refunded if the scheme participant is responsible for the termination of the scheme agreement.

Participation via coordinator per location/branch (But at least 100 €)	20

¹ Butchery businesses (incl. their associated locations/branches) with an annual turnover below €10 million can join the QS scheme via a coordinator. Those with a turnover above €10 million participate directly in the scheme and are classified in accordance with the relevant scale of fees for slaughtering/deboning and processing.

Food retail coordinators

The fees for scheme participation – plus the applicable value added tax – are due for payment at the beginning of each contract year. The lump sum fees for scheme participation cover the cost of scheme participation and the administrative expenses incurred by QS. The fees for scheme participation cannot be refunded if the scheme participant is responsible for the termination of the scheme agreement.
