### QS antibiotics monitoring – Registration of veterinarians

All QS farms that keep pigs, calves for fattening, broilers, turkeys (or their breeding poultry) or peking ducks participate in antibiotics monitoring. Cattle farms can participate in antibiotics monitoring on a voluntary basis. Veterinarians are fundamental partners in antibiotics monitoring as they report antibiotics applications and deliveries to the antibiotics database. This document summarizes the most important information on antibiotics monitoring for veterinarians.

To report antibiotics applications and deliveries of QS farms to the antibiotics database, it is necessary that veterinarians are registered with QS:

The registration is carried out as follows:

1. Select the website [www.vetproof.de](http://www.vetproof.de) (homepage of the QS antibiotics database).
2. Click on the button "Registrierung".
3. Change the language by clicking the flag in the lower right corner in the new window.
4. Fill out the registration form and click on "Submit".
5. You will receive the declaration of commitment and a data protection declaration by e-mail.
6. Sign the declaration of commitment and send it by e-mail or fax to QS ([antibiotikamonitring@q-s.de](mailto:antibiotikamonitring@q-s.de), fax: 0049 228 350 6810).
7. Send the signed data protection declaration by e-mail or fax to Qualitype GmbH ([service@qualitype.de](mailto:service@qualitype.de), fax: 0049 351 8838 2809).
8. After receiving the declaration of commitment, your access data will be activated in the QS antibiotics database and you can use the database.
9. If you are logged in to the database, you will find your VetProof ID, a veterinarian identification number, in the upper left corner behind your name.

The detailed requirements for the QS antibiotics monitoring are described in the guidelines for antibiotics monitoring for pigs, cattle and poultry. Here you will also find all information concerning you as a veterinarian. The guidelines are published on QS's website at [www.q-s.de](http://www.q-s.de).
